NOTICE OF THE 2020 GENERAL MEETING OF SHAREHOLDERS SPECIAL MEETING OF THE BOARD OF SUPERVISORS

If the Chairman of the Board of Supervisors is unable to attend the AGM, the Chairman of the Board of Supervisors shall be elected by the Board of Supervisors. The Company will issue the notice of the AGM to each of the members of the Board of Supervisors. Mr. Wang Xiaogang will preside over the special meeting of the Board of Supervisors. The Board of Supervisors has decided to elect Mr. Wang Xiaogang as the Chairman of the Board of Supervisors.

The financial data of the Company for the year ended December 31, 2019, has been audited by the accounting firm.
